- Members, as well as their guests, are expected to follow the posted rules governing the use of the Fitness Center.
- Please sign-in each time you use the Wellness Center!! A running record of the use of each piece of equipment is necessary in order to plan maintenance. Based upon the number of members using the Wellness Center, the record will also help determine if more equipment and space are needed.
- Please fill out the membership application and send it through **IN PARK MAIL** to the **Fitness Club**, along with the appropriate user fee. Checks should be made payable to **Roadhaven Fitness Club**.
- A membership sticker and a membership number will be sent to you. Affix the sticker to your Roadhaven badge and write your membership number in the appropriate space each time you sign in at the Fitness Center. Your badge must be worn while in the Fitness Center.
- Guests are **not** issued a membership number or sticker due to the short term of their stay (**14 Day Maximum**). Guests should sign in at the Fitness Center and insert the word "**Guest**" in place of the membership number.
